always controlled by the presuppositions of men and women. I say this not to demean science but simply to clarify the scientific enterprise. Therefore, to submit the Bible to the authority of science is to place the ideas of unbelieving men and women over the Word of God, the end result of which cannot possibly be anything other than atheistic, secular humanism.

- Belief in evolution compromises not only the Bible's teaching on creation but ultimately compromises faith in the gospel. "Creation" doctrines like belief in a historical Adam and Eve cannot be isolated from New Testament salvation doctrines, since Jesus was sent by God to remedy the problem created by Adam's fall. The biblical doctrine of sin and judgment results from the Bible's historical teaching on Adam, his first sin, and his position as the first of all humans. The biblical teaching on death as the curse of sin is radically revised under evolution, so that death is no longer an enemy of mankind but part of God's good, creative process. Moreover, the humanistic demands of secular science cannot be contained to creation doctrines. The same naturalism that rejects a historical Adam and Eve is unable to tolerate the virgin birth and bodily resurrection of Jesus Christ. For this reason, those who seek secular approval by abandoning biblical creation doctrine will find themselves under great pressure to reject the whole of Christian teaching.
- Belief in evolution is joined to a recent movement to deny the inerrancy of Scripture. The reason for this is obvious, since the plain teaching of Scripture cannot reasonably accommodate any form of evolution. To this end, Dr. Enns published a book in 2005 titled, Inspiration and Incarnation. In this work, for which Enns was dismissed from the faculty of Westminster Theological Seminary (my alma mater), he claims that since the Bible is both a human and a divine book it must contain error. To uphold biblical inerrancy, he insists, is to violate the "humanness" of Scripture. The effect of Enns' teaching is practically to eradicate the meaning of divine inspiration, so that Scripture is reduced virtually to the status of non-Christian sacred books.

What should we conclude from this controversy? First, we must become biblically discerning so that we cannot be easily led astray by appealing but deceptive assertions. Second, we must raise our children to know what they believe and why from the Bible, since the world they are entering is so hostile to biblical faith. Third, let us pray that God would have mercy by strengthening His churches to withstand such subtle assaults on truth and such a tempting accommodation that will ultimately cause us to lose the gospel.

The Nursery Reception scheduled for April 10th has been rescheduled. The new date will be announced later in the spring.


Use of Conference Room


Young At Heart

Letter From The Senior Minister The Recent Controversy over Theistic Evolution

Christians who are well connected to the internet are probably aware of a controversy that took place here in Greenville during the homeschool convention from March 17-19, 2011. The conflict arose from the appearance at the conference of Dr. Peter Enns, a noted proponent of theistic evolution, and the barring of Dr. Ken Ham because of his public criticism of Dr. Enns. Ken Ham is the founder of the Answers in Genesis ministry, as well as the Creation Museum, and is a strong critic of evolutionism. It is not my intention to weigh in on the controversy itself. However, being quite familiar with most of the people involved as well as with the issues, I thought it would be good to point out how the matters involved here are part of a broader challenge to biblical faith within the Evangelical movement in America.

At the heart of the homeschool convention controversy is the growing advocacy of theistic evolution among Evangelical scholars. Theistic evolution states that while God is the Creator of all things, Christians should agree with secular scientists in admitting that mankind came into being through evolutionary processes occurring over millions of years. Dr. Enns is the senior fellow for biblical studies of the Biologos Foundation, whose pro-evolution teaching is distributed on www.biologos.org. This foundation asserts that science has proven the truth of evolution and that honest Christians must be willing to accept this doctrine of human origins. Since evolution is at odds with established interpretations of Bible teaching, the Biologos website includes materials intended to point out errors in the Bible and offer new interpretations of biblical passages. An example is the series of articles in which Dr. Enns shows how the apostle Paul believed in a historical Adam and Eve but states that Paul was simply in error because of his scientific ignorance. Christians should be alarmed by this agenda and these teachings for a number of reasons, including the following:

• Despites all efforts to claim the contrary, belief in evolution – even so-called "theistic evolution" - unavoidably requires Christians to reject the Bible's history as false. Such a position is devastating to biblical faith, since the truths of Christian doctrine rely on the truthfulness of biblical history. Recognizing both the conflict with evolution and the importance of biblical history, pro-evolution scholars like Dr. Enns are proposing a new hermeneutic which will permit reinterpretations of historical passages in the Bible. For instance, it is increasingly taught in Evangelical seminaries, and many churches, that Genesis 1 is a poem that makes no attempt to teach historical facts. This is argued despite the reality that Genesis 1 does not fit established poetic literary standards. Christians need to beware of falling prey to glib assertions regarding the Bible that in reality serve the cause of unbelief rather than faith.

Belief in theistic evolution requires Christians to submit the Bible to the authority of secular science. Proponents like Dr. Enns freely admit that this is the case, arguing that Christians must accept that science is correct even if that admits that the Bible is wrong. Doing this makes a god of science and commits horrible idolatry against God and His Word. The reality is that science is never objective and is
