Between 2011, when the Presbyterian church authorized gay ordination, and 2013, the latest year for which figures are available, 428 of the denomination's churches left for more conservative denominations or dissolved, though some theological conservatives have remained as they decide how to move forward.

#### PCA PROMOTES A BIBLICAL VIEW OF MARRIAGE

The Office of the Stated Clerk of the Presbyterian Church in America (PCA) has received numerous emails regarding the recent action of the mainline Presbyterian Church (USA) in redefining marriage.

On March 17, 2015 the Presbyterian Church (USA) approved language that allows its ministers to officiate at same-sex marriages in its churches. The change comes after the General Assembly and a majority of that denomination's 171 presbyteries approved an amendment to their *Book of Order* that describes marriage as "a unique relationship between two people, traditionally a man and a woman."

There are several Presbyterian denominations in the United States. The Presbyterian Church in America (PCA), formed in 1973 as an evangelical denomination in the Reformed theological tradition, is the second largest. We, like other evangelical, conservative, orthodox, and traditional Christians from many branches of the Christian faith, believe that, from creation, God ordained the marriage covenant to be a unique bond between one man and one woman. This biblical understanding is what the Church has always believed, taught, and confessed. Therefore, we believe that the divinely sanctioned standard for sexual activity is fidelity within a marriage between one man and one woman or chastity outside of such a marriage.

Throughout history, there has often been a conflict between what the Church has believed, taught, and confessed and the society to which the Church ministers. The Church, in contrast



to the broader culture, is to base her views and practices on authoritative and timeless divine revelation found in the Holy Scriptures, and not on the changing and frequently subjective social practices within the society. The Church, therefore, has certain unchanging objective standards of biblical ethics.

This is especially challenging in this post-modern era of relativism. We think that the comparatively recent interpretation that biblical prohibitions against same-sex intimacy do not apply to "a same-sex marriage" is based on false premises and faulty reasoning and, therefore, is erroneous – no matter how well-intentioned.

The PCA in both its doctrinal standards (*Westminster Confession of Faith*, Chapter 24 "Of Marriage and Divorce") and church polity (*Book of Church Order*, Chapter 59, "The Solemnization of Marriage") affirms biblical marriage as being between one man and one woman. Neither the General Assembly nor any of the Presbyteries nor any Session (board of elders) of any congregation that is presently a member of the Presbyterian Church in America (PCA) has redefined marriage. Nor does the PCA intend to do so.

As we affirm what is sometimes called a traditional view of marriage, which we prefer to call biblical marriage, we seek to follow the apostolic practice of "speaking the truth in love." We reach out to all persons with the Good News by which we are being saved that "Christ died for our sins in accordance with the Scriptures, that he was buried, that he was raised on the third day in accordance with the Scriptures."

### Dr. Phillips on Recent News About Former PCA Church

The news broke this week that City Church San Francisco has reversed its prohibition against practicing homosexuals being admitted into church membership (see here). Previously, only celibate homosexuals were accepted as biblically faithful Christians. Senior Pastor Fred Harrell explained the shift on the basis of recent "social science research" that convinced him and his elders that inhibiting homosexual practice "has not led to human flourishing" (see the church statement). It strikes me from the reports of this shift, both at City Church and elsewhere, that the wrong lessons of history are being advanced while the right lessons are being ignored.

As for the wrong lesson, I have particularly in mind the analogy between homosexuality and racism. Here is the argument: in the past, Christians wrongly used the Bible to support racism and now the Bible is being used to support discrimination against homosexuals. Just as it took open-minded believers to show how the Bible urged tolerance for race, we now are urging tolerance for sexual preference.

I would argue that this is precisely the wrong lesson to learn from history. In fact, the prior example regarding racism and slavery argues against the acceptance of homosexuality in the church. Let me offer three reasons for this view: 1) whereas the Bible does not in fact support racism, it does prohibit homosexuality; 2) the analogy between race and sexual behavior is a false one; and 3) advocates for the acceptance of homosexuality are following the example not of those who opposed racism but of those who wrongly taught racism. By this last point, I mean that in prior generations the Bible was contorted to teach racism because Christians were conforming to the sins of the culture around them. Now, the Bible is being made to embrace homosexuality for the same reason: conformity to the sin demands of a perverse and ungodly world. I admit that my argument here assumes that it can be shown that the Bible condemns homosexuality as a sin. I would point readers to fine articles by Kevin DeYoung and Robert Gagnon, which make that very case.

If the advocates of homosexual acceptance are making the wrong lesson from history, what is the right lesson? The right lesson is that once Christians and churches compromise the authority of Scripture, they have stepped onto a slippery slope where there is no place to stand against worldly encroachments, however perverse they may be. I realize that the "slippery slope argument" causes many progressive Christians to turn red in the face with frustration. But the recent decision of City Church San Francisco is yet another data point proving that the argument is valid.

**Baker Family (Peru)**

The new school year starts on March 2 (or thereabouts) and we hope to have an enrollment of 75 kids. That is capacity and also very close to our breakeven point for the school. We hope to give between 15-25 scholarships this first year, some full and some partial. A full scholarship costs \$47/month. Our hope is to start the year with full enrollment and get off to a good start. The community seems to be excited about the school, but there still are many folks who are waiting to see how things shape up. We hope that we can make a good impression from the beginning and build confidence and trust in the community. Offering scholarships will go a long way toward building that trust.

On the church plant, we have two seminary students (Esdras Vargas and Emanuel Romero) who are about to graduate and have shown great promise as candidates for the ministry. I have been working with them (along with another young man who helps with university ministry) to write a plan for the new plant. They have begun visiting the neighborhood that we are targeting and have one group meeting for weekly bible study and they are about to start up a second study in the neighborhood. This will begin as an extension of Cristo Rey and I and the elders at Cristo Rey will be very involved at every step. We will rent a meeting place (Lord willing) in May and begin holding evening services there almost immediately. Then by September we hope to begin morning services. We have a budget for the project that consists of start up costs like basic furniture, musical instruments and basic sound equipment, paint, and publicity (\$15K), and ongoing support for rent, utilities, and salaries for the two men (\$3K/month). We believe that actual costs will be less than this, because we expect there to be participation from the core group almost from the beginning. Any extra funds that we receive would be directed to our general Church Planting fund, most of which would go toward planning and development of our next church plant.

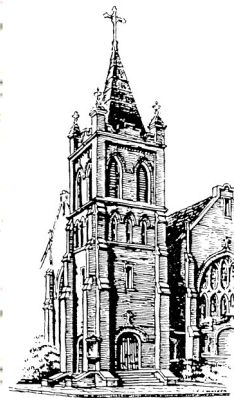

THE PCA VERSUS THE PCUSA: GAY MARRIAGE**

PCUSA EMBRACES GAY MARRIAGE (Not the PCA)

NEW YORK – The Presbyterian Church (U.S.A.) approved re-defining marriage in the church constitution Tuesday to include a "commitment between two people," becoming the largest Protestant group to formally recognize gay marriage as Christian and allow same-sex weddings in every congregation.

The new definition was endorsed last year by the church General Assembly, or top legislative body, but required approval from a majority of the denomination's 171 regional districts, or presbyteries. The critical 86th "yes" vote came Tuesday night from the Presbytery of the Palisades in New Jersey.

After all regional bodies vote and top Presbyterian leaders officially accept the results, the change will take effect June 21. The denomination has nearly 1.8 million members and about 10,000 congregations.

Last year, the church had allowed ministers to preside at gay weddings if local church leaders approved in states where the unions were legally recognized. The new wording for the church Book of Order, which authorizes same-sex marriages churchwide, will read, "Marriage involves a unique commitment between two people, traditionally a man and a woman, to love and support each other for the rest of their lives."

Church leaders released statements Tuesday urging "mutual forbearance" amid disagreements over the amendment. "We hope that such 'up/down' voting does not mark the end, but the
