each presbytery and met for 3 days (before and) during GA to give Assembly its recommendations. Along with TE Richard Thomas from Spartanburg I served on this committee.

**Overture 1** established the possibility of a new judicial commission on the presbytery level. The Committee recommended a **rejection** of this and that recommendation was upheld by the Assembly. Too much centralization of authority on the presbytery is not needed.

Overtures 2 and 9 requested a national study committee regarding "recreation on the Sabbath." The Committee recommended a rejection of that overture. That recommendation was upheld by the Assembly. While there is diversity of principle and practice with regard to Sabbath observance by PCA office-bearers, study committees tend to normalize existing views and sometimes broaden them in practice. In this case the Assembly said it is happy where everything now stands.

Overture 3 requested a change in the wording of PCA baptismal vows. The Committee recommended a **rejection** of that overture. That recommendation was upheld by the Assembly. The current baptismal vow uses the word "dedicate" (often a term found in Baptist formulas for baby dedications). Assembly by rejecting this change was affirming the existing 125 year old Presbyterian vow and in the context of debate / discussion reminded ministers to explain how baptism in a reformed context is not merely a ritual, but a sign and seal of the covenant of grace.

Overtures 4-6 created new presbytery boundaries (including 3 new presbyteries in the South Carolina Lowcountry). Those overtures were assigned to the Mission to North America Committee. Growth in the PCA means growth in the apparatus of regional government. After this Assembly we will have almost 90 Presbyteries. We began the denomination with 8 presbyteries, primarily in the Southeast in 1973!

Overture 7 asked for stronger language that would compel church officers to testify in judicial cases related to doctrine/heresy. The Committee recommended that this overture be approved. This recommendation was, after some debate, **rejected** by the Assembly. Clearly more work needs to be done here for the purity and peace of the church.

Overture 8 dealt with the issue of men who have been approved for ministry but do not have calls (jobs) for many years and yet remain on the rolls of a presbytery. The Committee recommended a **rejection** of that overture. That recommendation was upheld by the Assembly. The thinking was each presbytery should govern itself in these matters and one size does not fit all.

**Overture 10** established a provisional presbytery in Paraguay and was sent to the Mission to the World Committee.



Lastly TEs Sean Michael Lucas of Grace Presbytery and J. Ligon Duncan III of Mississippi Valley Presbytery sent a **personal resolution** relating to the *sin of indifference* by churches that helped form the PCA with regard to the plight of the African American community during the Civil Rights era. The motion challenged individual congregations and presbyteries to look into their own histories and search out incidents of racism and bigotry that are an offense to the Gospel of Christ, and called on the PCA in a general way to confess its denominational sins.

Overtures Committee spent almost 10 hours deliberating on the matter and after hearing from African American Ministers who cautioned the committee to move slowly in response recommended that the resolution be referred to the next GA.

When this issue was debated on the floor of GA there were many emotional speeches about the need to take some action for the sake of unity. After 90 minutes of debate, which was extended several times so that more Commissioners could speak, the Assembly approved the Committee's recommendation. Several hundred commissioners formally protested this (in)action. However in the language of the motion itself (to refer) it was acknowledged that work *must and will be done* on this issue next year. I am confident that the PCA will move forward in the years to come. This issue being finished the Moderator called for a lengthy and frankly lovely time of corporate prayer that lasted until almost midnight.

The General Assembly ended with your humble Church Administrator reading a Resolution of Thanks to the highest Court of the Church, something I have been privileged to do now several times, acknowledging God's goodness and sovereignty over the Presbyterian Church in America.



# Letter from the Church Administrator **General Assembly Report**

This past week Second Presbyterian Commissioners TE Richard Phillips, TE Robert Spears, RE David Bragdon, RE Ken Safford and RE Melton Duncan attended the 43rd PCA General Assembly in Chattanooga. The theme of the week was: "Anchored in Christ, Active in Culture."

"GA," a yearly meeting of the denomination attracted over 1300 commissioners (roughly 1000 "teaching elders" and 300 "ruling elders") from all over the world. GA is many things; a business meeting, prayer meeting, missions conference, theology conference, networking event and a trade show all packaged for PCA people.

The name the PCA gives its representatives is "Commissioner" and reminds a watching world that the PCA is a denomination that cares deeply about the work of the Great Commission. By God's grace the PCA is a growing church that combines a high view of Scripture, reformed theology and a robust commitment to missions and evangelism.

There were a smaller number of business items before the church court this year, and I would characterize the response from the highest court of the church as essentially "NO" to most requests.

The "Overtures" Committee reviews most of the issues properly "brought" to GA by a presbytery or a local session and gives a recommendation to the Assembly as a whole. The Assembly can accept the recommendation, they can reject, they can send back the overture to be reconsidered, or they can postpone the overture to the next year's General Assembly. There were 10 overtures from presbyteries and some additional personal resolutions. The PCA is a "grass roots" denomination and is committed to giving its churches and elders access to the church courts.

The Overtures Committee is made up of two representatives from
